We, Bihari Shah & Co., Chartered Accountants, having Firm Registration Number 119020W, were appointed as the Statutory Auditors of Global Infatech & Finance Limited under the provisions of Section 139 of the Companies Act, 2013 to hold office for a period of 5 years.

We hereby tender our resignation from the position of Statutory Auditor of the Company after conclusion of forthcoming AGM, due to the following reason:

Reason for resignation:

The professional effort and resources required for auditing a listed company have increased significantly over time, while the audit remuneration remains commercially unviable. Despite discussions with the management, we could not arrive at a mutually agreeable fee structure. Therefore, in order to maintain professional objectivity and audit quality, we consider it appropriate to step down.

We confirm the following:

- We have concluded the statutory audit of the standalone and consolidated financial statements of the Company for the quarter ended June 30, 2025, and have issued our audit report on July 25, 2025.
- There are no other material reasons for our resignation other than those stated above.
- We have no objection if the Company files this resignation letter with the Registrar of Companies, Stock Exchanges, and other regulatory authorities, as required under applicable law.

Please find enclosed herewith Annexure A; (information to be obtained from the Statutory auditor upon resignation), as required by SEBE Circular SEBI/HO/CFD/PoD2/CIR/P/0155 November 11, 2024.
